Eligibility & Guidelines

- •The nominee must be in a member district of the Council of the Great City Schools.
- •The nominee must be employed by a member district on the date of the award. Chief Academic Officers, Curriculum Directors, Curriculum Coordinators and Specialists are eligible for nomination.
- •The nominee must have held his/her position, or equivalent position, for the past two school years.
- •The nominee must be remaining in the district for the 2013-2014 school year.
- •The winner must be in attendance at the meeting.
- •All nomination forms must be submitted by June 7, 2013.
